Food Vendor Guidelines

- You are invited to apply for concession space in the NC Honey Festival set for Saturday, September 9, 2023 in downtown Whiteville, NC.
- The fee for vendors is \$90.00. The full fee must be submitted with your application. No refunds will be made unless the application is not accepted.
- Electric hook ups are limited and will be available on a first come basis. Please let us know your needs in your application.
- Spaces will be approximately 12 feet x 20 feet and will be on Madison Street. Set up for Food Vendors should be completed no later than 9:45am.
- **Applications must be received no later than August 25, 2023** and applicants will be notified of participation decision no later than August 28, 2023. The number of spaces will be limited. The committee will determine space assignments. Requests for specific space locations will be honored on a first-come, first-served basis.
- If you wish to apply, please submit your completed Vendor Application, \$90.00 fee, (make payable to NC Honey Festival), the Temporary Food Service Permit Application (required for the Health Department), and the Food Service Permit fee of \$75.00 (make payable to Columbus County Health Department).
